FOR EVALUATION OF DAMAGES CAUSED IN THE MUNICIPALITYS DURING THE TURBULENCE OF 17-18 MARCH 2004 AND THE PROCCEDING SO FAR FOR THEIR RENOVATION.

MITROVICA MUNICIPALITY

Damages according to the assessment:

Handed for process of tendering: 2 Tenders of 15 houses (Cat. II (7), III (22), IV (1), Total 30 houses. (later the separation was made on three tenders)

The evaluation was completed by the appointed commission and the announcement of the winning companies was made, as well the contracts with three companies were signed.

- "FITIMI" company from Mitrovica, for 15 hoses 99,639.63 €
- "BASHKIMI" company from Proshtina for 7 houses 64,259.54 €
- "EXKOS" company from Zubin Potok for 8 houses 40,738.31 €

The beginning of works for rehabilitation of these houses started on Tuesday on 01/06/2004. The municipality has promised that for the houses of Category IV and V the documentation for tendering will be prepared by municipality.

But because of noncomplement by municipality officers this date is postponed for 01/06/2004
